652 JONATHAN WEST⁵ (Peter West⁴, Francis West³, Susannah² Soule, George¹) b. West Greenwich RI ca 1740 [1] and d. Saratoga (Albany) NY/Canada? 1790 - 1800 (before 22 Nov 1792?) [2].

Jonathan West m. RI/MA? (after 3 Mar 1756) ca 1766 **ELIZABETH??** ----[3], daughter of -----[4]. She was apparently b. ca 1745 [5] and d. Saratoga (Albany) NY? (after 22 Nov 1792?) ca 1804 [6].

[Father] Peter West and his family including Jonathan were ordered to be escorted back to West Greenwich RI by order of the Exeter RI Town Council dated 3 Mar 1756 [7].

[Father] Peter West was taxed 1770 in North East Precinct (Dutchess) NY [8]. Jonathan and [brother] Francis West were signers in Beekman's Precinct NY 1 July 1775 [9].

[Son] Jonathan West and [son-in-law] Arthur Coldwell were married to their respective spouses in an apparent double wedding in Bengal (Dutchess) NY 24 Jan 1790 [10].

For 1790 one Jonathan West is listed in Saratoga (Albany) NY with (1,0,1) next to Arthur 'Calwell' with (1,0,2) [11]. Another Jonathan West [son] is listed in Saratoga

(Albany) NY with (1,0,1), near [nephew?] Thomas West with (1,1,3), and also near [son] Stephen West with (1,0,2) who is next to [son-in-law] Arthur 'Colwell' with (1,1,1) [12]. A third [unrelated?] Jonathan West is listed for 1790 in Stephentown (Albany) NY with (1,0,2) [13].

One Elizabeth West, possibly widow of Jonathan, was received by request 22 11mo 1792 by Easton and Saratoga MM (NY) [14]. Martha West, formerly Clark, was married out of unity and dismissed 24 5mo 1797 from the same MM [15].

Stephen and Jonathan West, of Saratoga NY, bought 139 acres in Saratoga Co. NY 28 Mar 1794 [16].

On 18 6mo 1800 George West was received on request in Easton and Saratoga MM [17]. On 22 10mo 1800 Stephen and 'Pheny' West were received on request in the Easton and Saratoga MM, which means they were not members of the Friends prior to that time; on the same date Martha West acknowledged her lapse (marriage out of unity) and was restored to membership [18].

For 1800, [son?] Jonathan West is found in Galway (Saratoga) NY with (40010 01010), next to [son] Stephen West with (20010 10100), and near [son-in-law] Arthur Caldwell with (31010 01010), [son] Joseph West with (10010 10100), and [son] George West with (30010 10010) [19].

On 22 Feb 1805 [son?] George and Triphena West and family received a removal certificate from Galway MM (Saratoga) NY to Farmington MM (Ontario) NY (received 27 6mo 1805 at Farmington MM), with later removal from Scipio MM (Cayuga) NY 19 Jan 1825 to Rochester MM (with son Isaac) and then on 23 9mo 1831 given a removal certificate to Collins MM (Erie) NY (Hicksite), where the family resided in the village of Brant (Erie) NY for the 1840 census [20]. For 1810 George West is found in Aurelius (Cayuga) NY with (12101 00010) [21].

On 9 Sept 1808 [son?] Stephen and Martha West and their family also received a removal certificate 21 Sept 1808 from Galway MM to Scipio MM (Cayuga) NY and then on 15 Sept 1825 to Collins (Erie) NY [22]. The 1825 certificate names children: James, Ruth, Mercy, Stephen. and Benedict. Stephen and Martha West were Hicksite in Collins MM (Erie Co. NY) after the 1828 separation although their children sided with the Orthodox faction: George and Triphena were also Hicksite in Rochester MM (Monroe Co., NY) for the 1828 separation [23].

For 1810 Jonathan West is found in Galway (Saratoga) NY with (02210 10020) along with Joseph West with (31110 11110) and Arthur 'Colwell' with (21101 20101) [24].

The will of [son?] Joseph West, of Galway (Saratoga) NY, dated 15 Feb 1813 and Proved 1 Mar 1813 names as executor his brother Jonathan West [25]. On 8 Mar 1813 Jonathan West petitioned to the Surrogate's Court that Henry Hays and Alexander S. Platt be appointed guardians for his brother Joseph West's six children, who had "lost father and mother" [26].

For 1850 [son?] Stephen West, b. ca 1770 MA, is in Brandon (Oakland) MI with his son 'Burdick' West [27]. For 1850 [son?] George and Tryphena West are with their son Stephen and family in Brant (Erie) NY [28]. For 1850 [son?] Jonathan West, 82 NY, and Betsey West, 63 NY, and family are in Galway (Saratoga) NY [29].

NOTE: Y-DNA testing of some West lineage men who are descended from this family would be helpful to confirm the placement of the sons, Jonathan, Stephen, George, and Joseph.
